**IV. NEW BUSINESS**

**A. Academic Achievement – AP Recognition/Four Star Information**

Dr. Killion reported on June 14, 2017 Randy Studt, Dan Walbaum and a student will attend an Indiana Department of Education award ceremony honoring Advanced Placement students. To be selected, schools must have at least 25 percent of their 2016 graduating class receiving a 3, 4, or 4 on an AP exam. Congratulations to our Jr. Sr. High School. Also, the Four Star requirements have been recalculated by the Department of Education and we are now a Four Star school corporation. Congratulations to staff, students, parents and community.

**B. Academic Achievement – Strategic Plan Update Timeline**

Dr. Killion reported – Dr. Janet Emerick has agreed to help the corporation develop the next 5-year strategic plan. She assisted the corporation in 2010 along with a committee. The committee will be called back to meet in the spring of 2018. Committee is comprised of Board members, teachers, administrators, staff, retirees and parents.

This CMC would be utilized for the Jr. Sr. High School project and the old Happy Hollow Elementary project. If the RFP comes back and it costs the school corporation too much money, then the school corporation will move to other ideas.
