Organizational Meeting of the Board of School Trustees Happy Hollow Building, LGI Room 1200 N. Salisbury Street West Lafayette, Indiana

I. ROUTINE BUSINESS

II. NEW BUSINESS

A. <u>Election of Officers</u>

Dr. Springer reported she received input from all seven Board members regarding Board officers for 2022. The majority endorsed Mrs. Rachel Witt for President.

There are many other committees Mr. Marley participates in, so he is extremely knowledgeable and wants to do everything to help the students because this is what it's all about.
