SUBJECT: Reuter Consulting Services

Recommendation will be presented at the Monday, April 4, 2022 School Board of Trustees Meeting to retain the services of Michael A. Reuter Consulting Services, located in Fishers, Indiana.

- The consultant agrees to prepare a fiscal plan for internal management. The plan will contain/include:
