A. Appointment of Interim Superintendent

Recommendation: President Karpick recommended the appointment Mr. Ross Sloat as the Interim Superintendent effective December 17, 2021 through January 31, 2022.

Discussion ensued.

A motion was made to approve the appointment of Mr. Ross Sloat as the Interim Superintendent of WLCSC effective December 17, 2021 through January 31, 2022.

B. Approval of Superintendent Contract

Recommendation: President Karpick recommended the approval of the new Superintendent Contract effective January 31, 2022.

C. Appointment of New Superintendent

A motion was made to approve the appointment of Dr. Shawn Greiner as the new West Lafayette Community School Corporation Superintendent effective January 31, 2022.

Discussion ensued with Board members expressing welcome to Dr. Shawn Greiner and his family to the West Lafayette Community School Corporation and to the West Lafayette Community. In her remarks, Dr. Yin began restating comments previously heard in public meeting. Mrs. Austin called the question, a request to end debate and vote. Dr. Springer seconded the motion. The motion passed 6 to 1 with Dr. Yin voting no.

President Karpick called for the vote on the appointment of Dr. Shawn Greiner as the new West Lafayette Community School Corporation Superintendent previously moved by Mr. Marley and seconded by Mrs. Austin. **Vote: 6 of 7, Dr. Yin-No.**

Members of the West Lafayette Jr/Sr High School Band played “Scarlet and Gray” as a Musical welcome to the Greiner family. Dr. Greiner addressed the packed room with his appreciation of being selected as the next WLCSC Superintendent and his eagerness to move to West Lafayette, to listen to corporation stakeholders, and to learn about the corporation and WL community. Mrs. Austin had coordinated a gift basket and flowers for the Greiner family and two students from WLES and two students from WLIS presented those gifts.

III. ADJOURNMENT – The meeting was adjourned at 6:00 p.m.


